**I. Items of Discussion:**

**2018 Black & White Charity Fundraiser**

- a) Parking would be free in the Garage across the street and valet parking would be provided for \$5.00 instead of their standard \$15.00. Because Whitney Peak does not have gaming they do need to charge for valet parking and are not willing to waive the fee.
- b) The committee reviewed the Sponsorships that we had last year and created some new, additional ones:
  - \$300 Auction Paddle Sponsor – Paddles will be logoed with the Sponsor Name , RSAR & the Charity.
  - \$300 Champagne Bar Sponsor - We will have a Champagne Bar for the first hour & the champagne will be free.
- e) The committee agreed to keep the theme of a “Black & White Affair,” but we are changing title to “Black & White Affair with a Flair.”
- f) The general consensus of the committee was to keep the ticket prices the same as last year at \$65 each. Prices may need to be raised because a red meat meal option will be included and the ticket price needs to cover the meal and any cocktails that are included.
